Instructions to Bidders (ITB)

- Scope of Work and qualification of the bidder: icddr,b, hereinafter referred to as the Purchaser/ icddr,b as detailed in the Tender Data Sheet-TDS, Specifications with Bill of Quantity/Proposal Guidelines, invites sealed bids for supply of Goods and/or Services or as detailed Price Bid schedule/Proposal Guidelines (Annexure-I)
- 2. Eligibility of the Supplier: The supplier/service provider/institutes (hereinafter referred to as the bidder /supplier /firm) must be a legal business entity in the country with sufficient experiences in the relevant field of supplies of goods/rendering services. The bidders were, in any capacity, not involved, directly or indirectly, with any project of icddr,b or firm which were under contract with the icddr,b for the preparation of the design, specifications and or other documents to be used for the procurement of goods under this tender or invitation to Bid
- 3. Bid document will be available in the icddr,b website (http://www.icddrb.org/work-with-us/tender-notices) and the responses for the received query will be circulated via email to all pre-bid participants.
- 4. Format and signing of the Bid: The bids must be submitted with the attached prescribed forwarding letter of icddr,b. The bids shall be typed or written in language stated in the Tender data sheet/proposal guidelines with indelible ink and shall be signed by the Bidder or person(s) duly authorized by the bidder stamped with the name, designation and company name, in the latter case, letter of authorization is to be accompanied the bid. The person or persons signing the bid shall initial all pages of the bid, along with the un-amended printed literature with official seal on. Any interlineations, erasures or overwriting shall be valid only if it is initialed by the signatory.
- 5. Cost of Bidding: The Bidder shall bear all costs associated with the preparation and submission of its bid and icddr,b in no case, be held responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- 6. Bid submission: The bidder shall prepare two separate sealed envelope for technical and financial bid clearly marked as "TECHNICAL" and "FINANCIAL". The Purchaser may reject a bid if technical and financial document is not submitted in a separate envelope as detailed in the instructions of the tender notice or RFO.
- 7. Price schedule: The bidder must quote price including VAT as per the price bid schedule format. All quoted prices shall be included with the costs of delivery and installation and commissioning unless separately asked in the price bid schedule. Quoted prices, delivery period and specifications cannot be amended or modified after submission of the bid.
- 8. Error in Bid: In case of error in the extension of prices in the bid, the unit price governs. No bid shall be altered or amended after the specified time for opening of bids.

- 9. Role of Consignee: Consignee will be treated as the concerned official(s) of icddr,b or any other authority as determined by icddrb in the bid documents (TDS/ proposal guideline) or subsequent Purchase Orders to accept or reject the delivery of goods or works in accordance with the Purchase orders and thus, certifying the challans/bills
- 10. Technical Specifications and other related documents establishing Goods' Conformity to Bidding Documents: Bidders must clearly write the technical specifications/ information/ data of the goods or services for which the bid is invited; otherwise bids may be rejected. If bidders are to quote substitutes or equivalent goods of the listed items, they must provide detailed information including brand/model name of other important aspects of that substitutes or equivalent. Otherwise, quotes for that particular item will not be accepted.
- 11. Documentation establishing bidders qualifications: The bidder shall be qualified enough as detailed in the TDS/proposal guideline, to perform the contract if its Bid is accepted. In this effect, the Bidder shall furnish evidence of its status as a qualified Supplier as outlined below:

 a. Technical capacity: Bidder shall furnish all required documents (refer to relevant section of bid data sheet (Annexure-IV) to the satisfaction of the icddrb, establishing Bidder's qualification in terms of required technical capacity (previous business experience, after sale service) of supplying similar goods or rendering similar services to perform the contract.
 - b. Financial capacity: Bidders shall furnish supporting documents (refer to relevant section of bid data sheet (Annexure-IV) demonstrating the availability of liquid assets to successfully complete the contract.
- 12. Completeness of Bids: The Bidder is expected to examine all instructions, Forms, terms and specifications in the bidding documents. Unsigned bids/quotation or failure to furnish all information required by the bidding documents or submission of a bid not responsive to the bidding documents in any respect will be at the Bidder's risk and may result in rejection of his bid.
- 13. Pre-bid meeting: icddr,b shall request the bidder to participate in the pre-bid meeting for clarifications of the bid schedule, terms and conditions and other related to the bidding, if deem necessary
- 14. Amendment of Bid documents/tender schedule: Any modification, revision or correction in the tender documents including specifications and drawing/design will be made only by addendum whether at its own initiative or in response to a clarification requested by a prospective bidder and the addendum notice will be floated in the Notice board or to be sent to bidders invited under RFQ at least 3 days prior to the closing date of bids which will be notified over telephone if numbers are available in the Tender collection data sheet. Should it become necessary to issue an addendum within the three-day prior to the bid opening, the tender closing date may be reset giving bidders ample time to comply with the addendum.
- 15. Clarification of Bids: The purchaser may ask the bidder to provide clarification on design, technical or functional features of the goods, terms and conditions, which doesn't affect the selection criteria, as offered in its bid for evaluation and comparison purposes.
